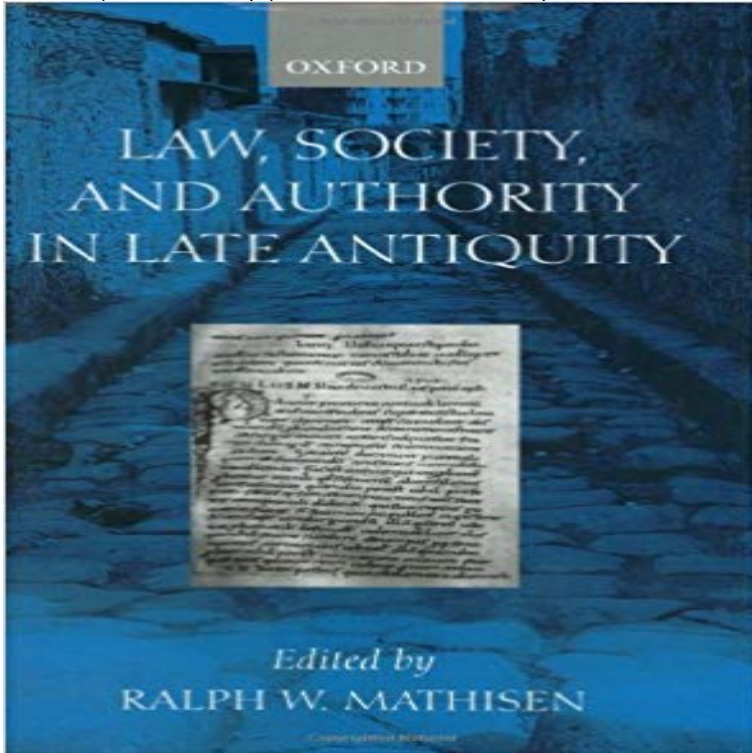


Law, Society, and Authority in Late Antiquity
