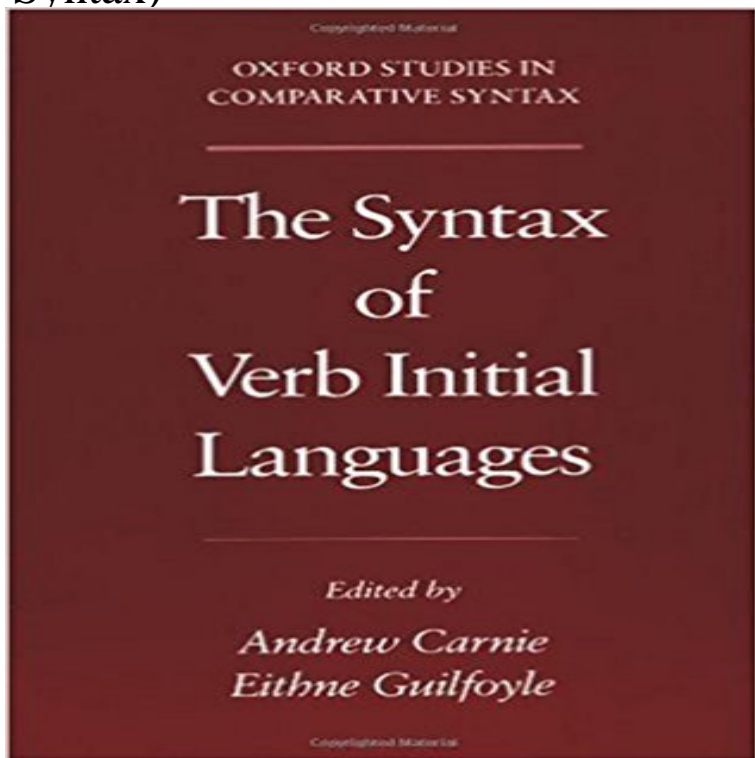


# The Syntax of Verb Initial Languages (Oxford Studies in Comparative Syntax)
