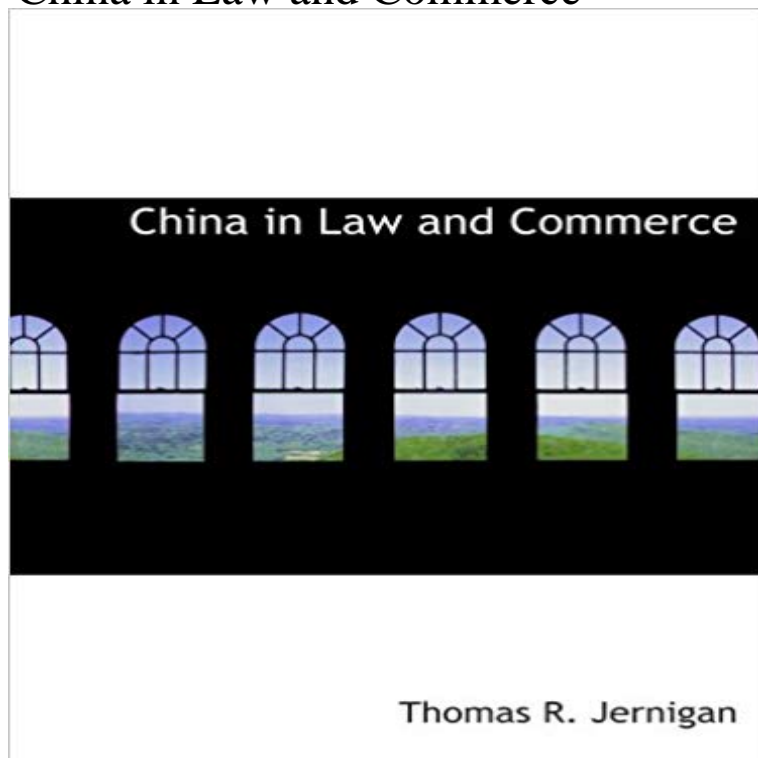


## China in Law and Commerce
