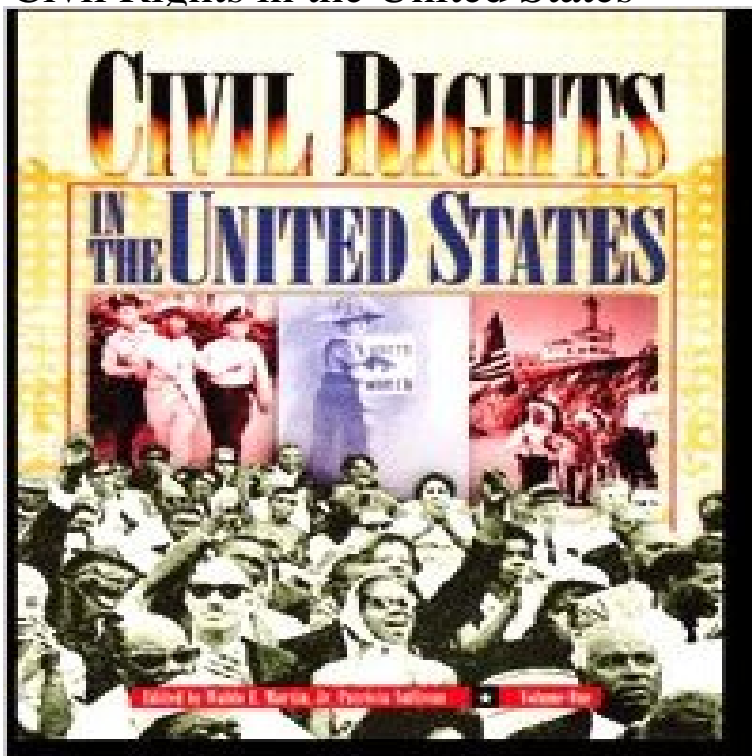


## Civil Rights in the United States
