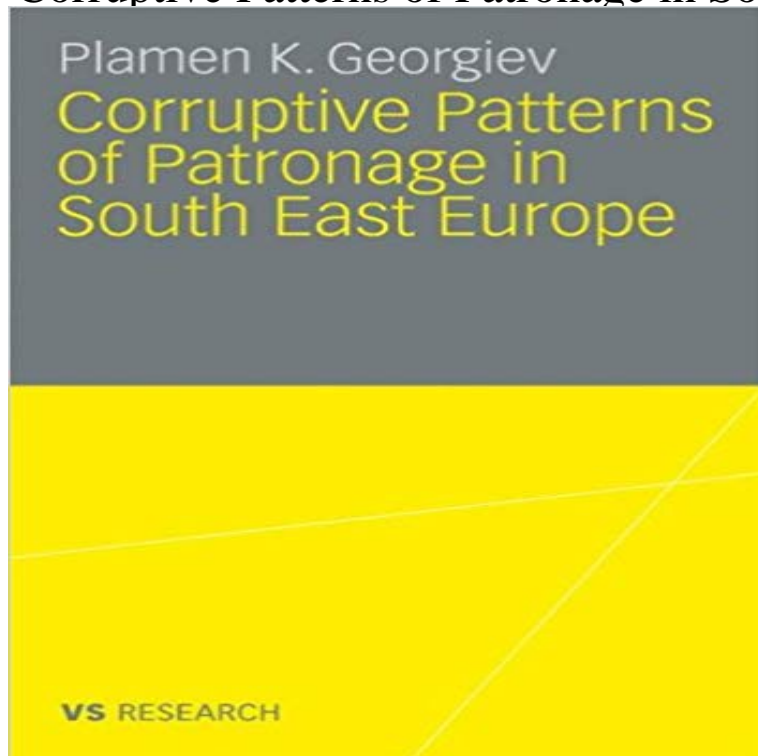


Corruptive Patterns of Patronage in South East Europe
