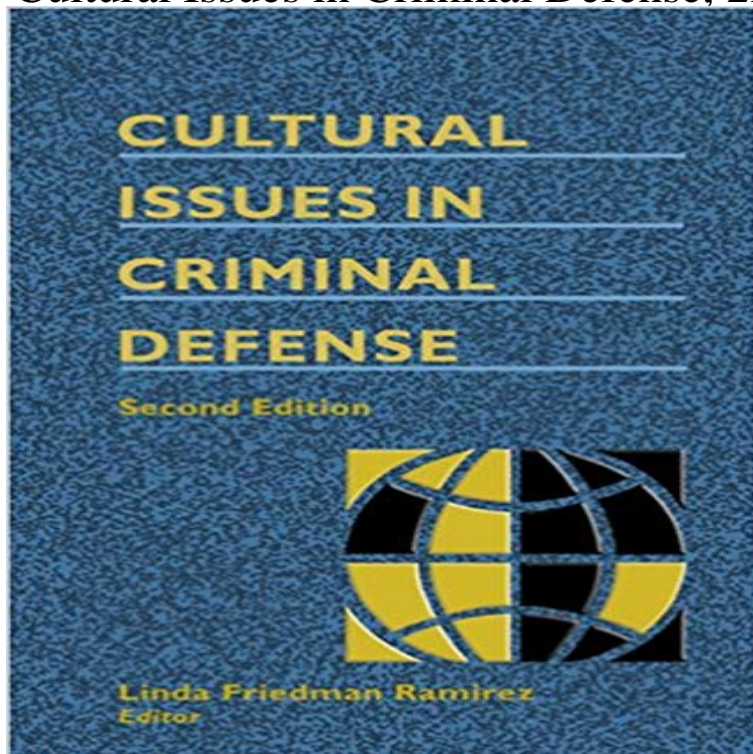


## Cultural Issues in Criminal Defense, 2nd Edition
