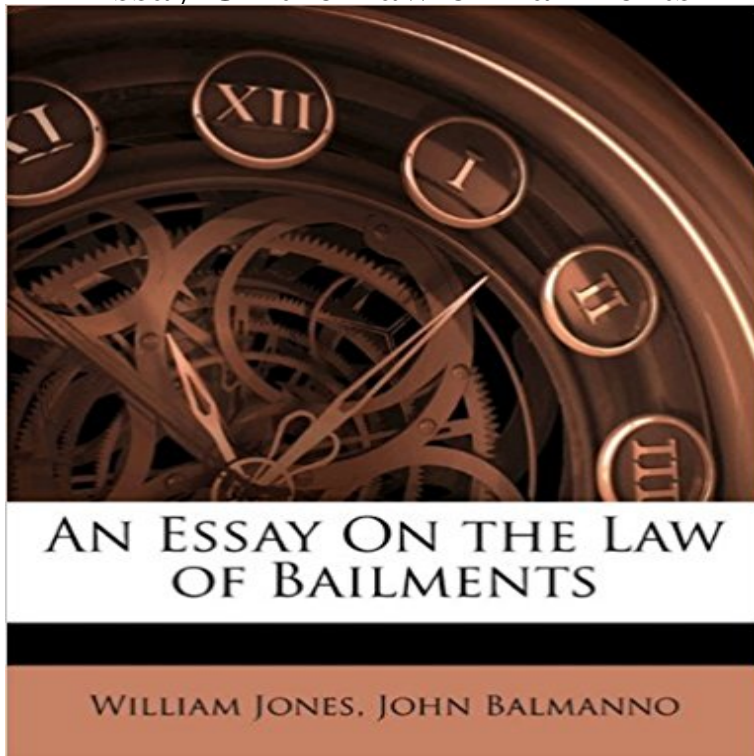


An Essay On the Law of Bailments
