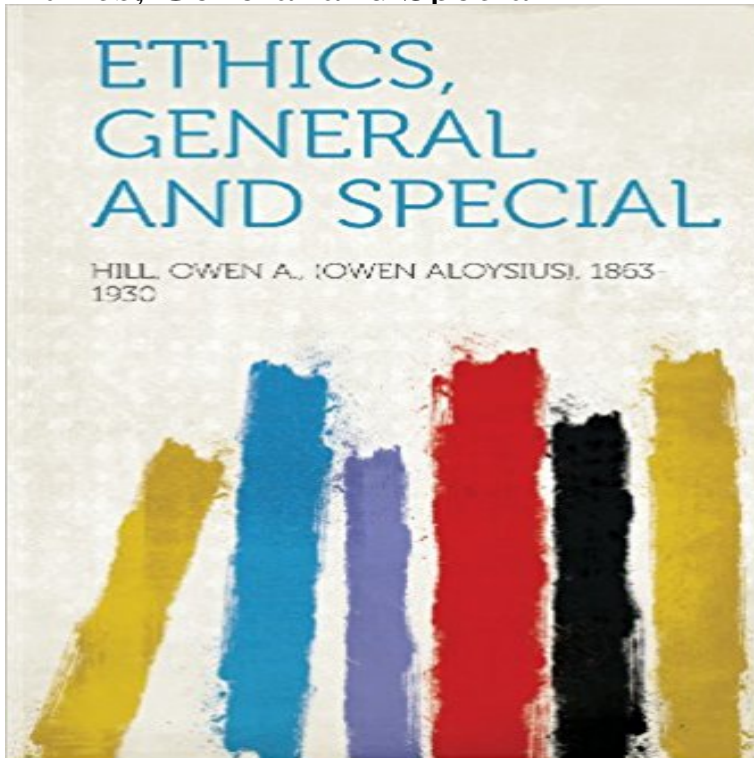


## Ethics, General and Special
