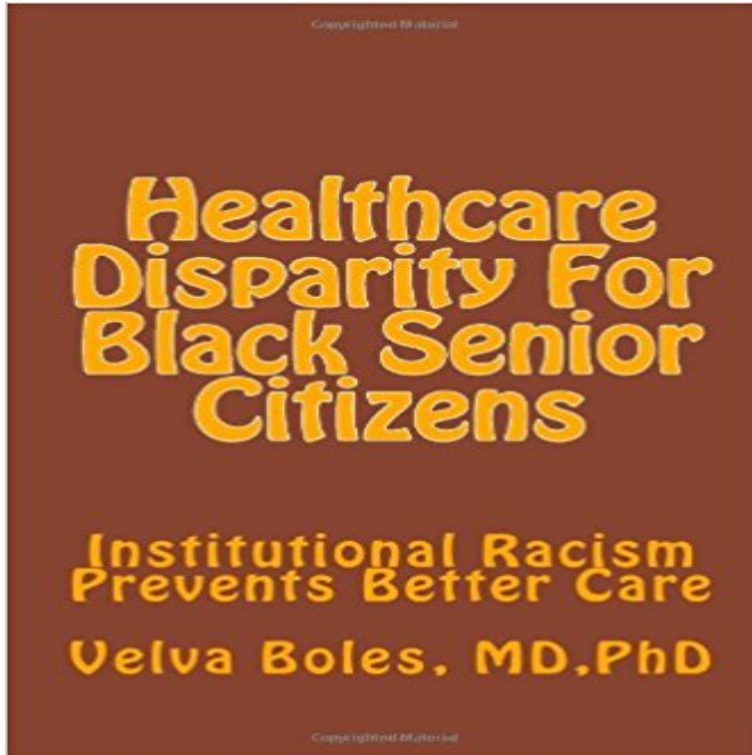


Healthcare Disparity For Black Senior Citizens: Institutional Racism Prevents Better Care

follow-up care. There are data to support that health care providers unconsciously or consciously treat certain racial and ethnic patients differently than white patients. Without health insurance, patients are more likely to postpone medical care, more likely to go without needed medical care, and more likely to go without prescription medicines. Black Americans in the United States lack insurance coverage at higher rates than whites. According to the 2009 National Healthcare Disparities Report, uninsured Americans are less likely to receive preventive services in health care. Preventative care is paramount to stopping the root causes of disease as well as detecting diseases in their early stages when treatment is most effective. Health literacy varies by context and setting and is not necessarily related to years of education or general reading ability. A person who functions adequately at home or work may have marginal or inadequate literacy in a health care environment. Low health literacy is linked to higher rates of hospitalization and higher use of expensive emergency services. Health literacy is not simply the ability to read; it includes the ability to understand instructions on prescription drug bottles, appointment slips, medical education brochures, doctors directions and consent forms, and the ability to negotiate complex health care systems. It requires a complex group of reading, listening, analytical, and decision-making skills, and the ability to apply these skills to health situations. While problems with health literacy are not limited to minority groups, the problem can be more pronounced in these groups than in whites due to socioeconomic and educational factors. Low-income Americans and racial and ethnic minorities experience disproportionately higher rates of disease and reduced access to care. The National Academy on an Aging Society estimated that health care costs were about \$73 billion. To compound things, many seniors are poor health historians.
