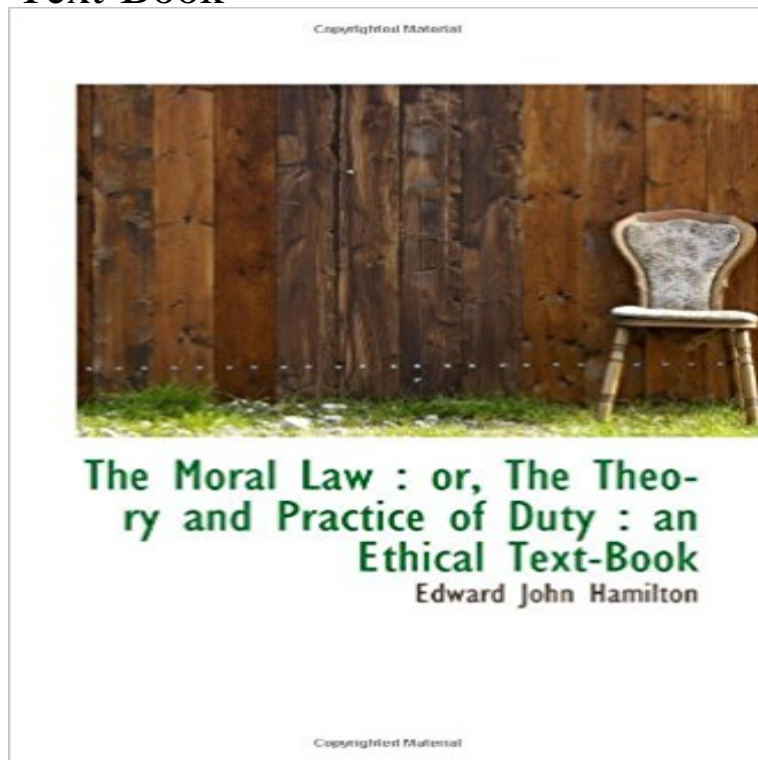


The Moral Law : or, The Theory and Practice of Duty : an Ethical Text-Book
