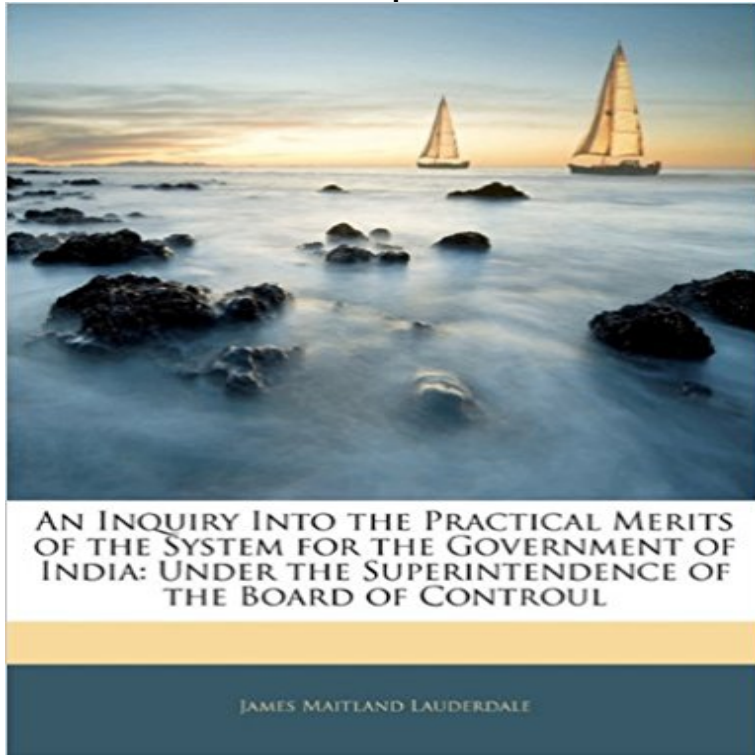


# An Inquiry Into the Practical Merits of the System for the Government of India: Under the Superintendence of the Board of Controul
