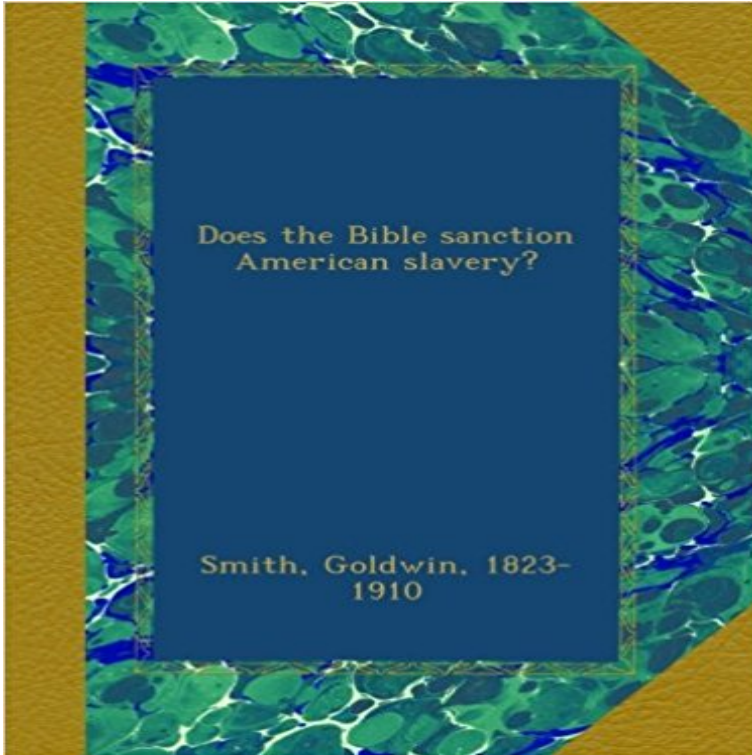


## Does the Bible sanction American slavery?
