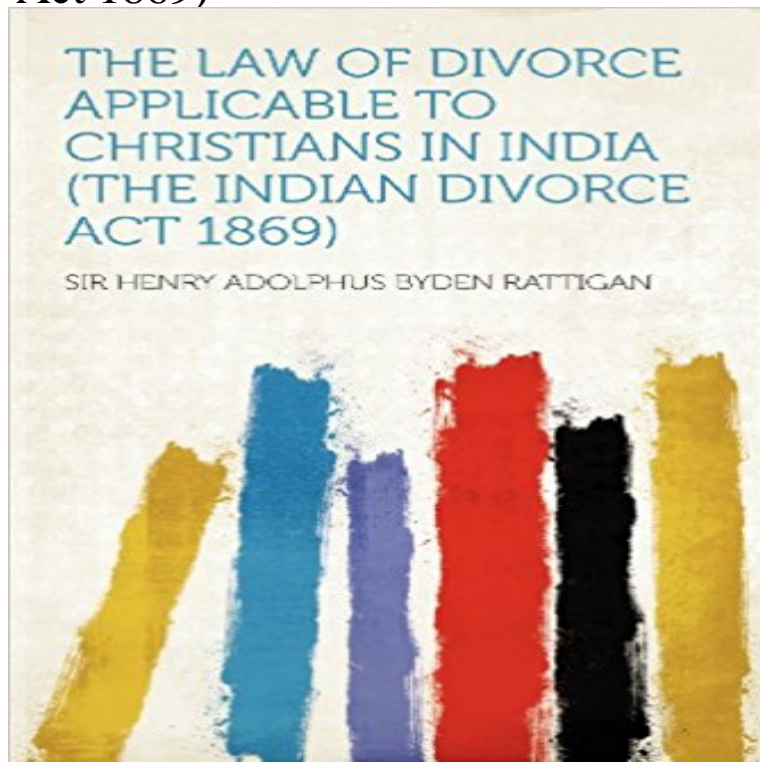


The Law of Divorce Applicable to Christians in India (the Indian Divorce Act 1869)
