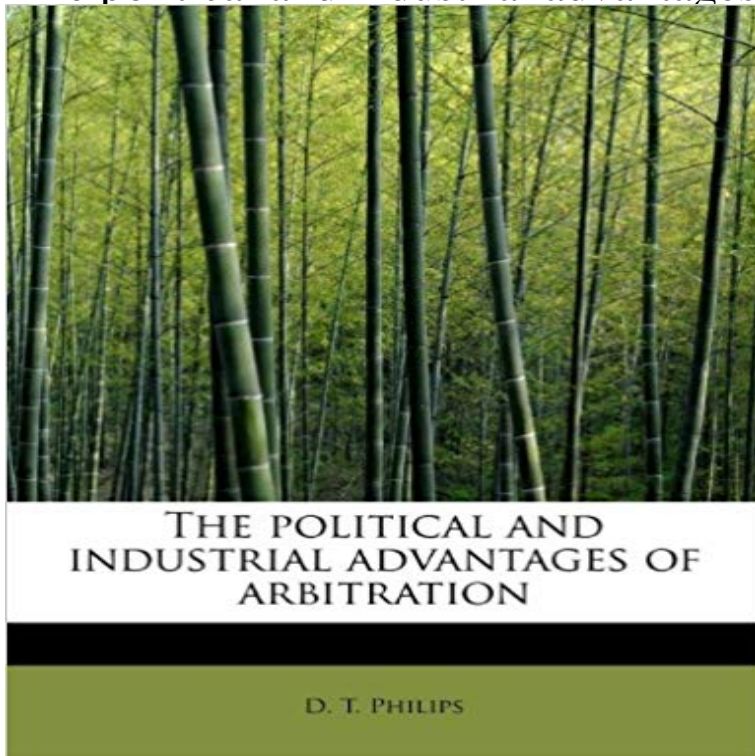


The political and industrial advantages of arbitration
