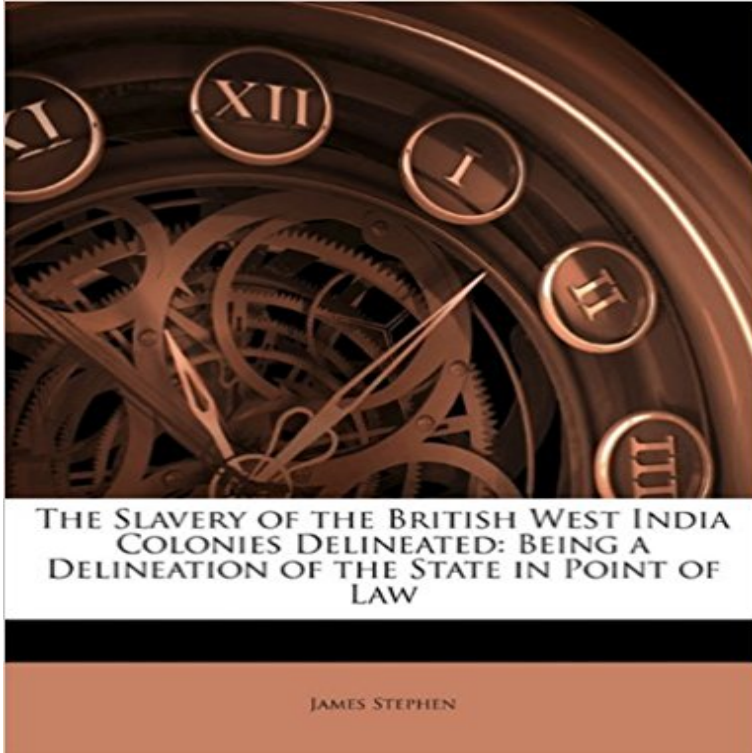


# The Slavery of the British West India Colonies Delineated: Being a Delineation of the State in Point of Law
