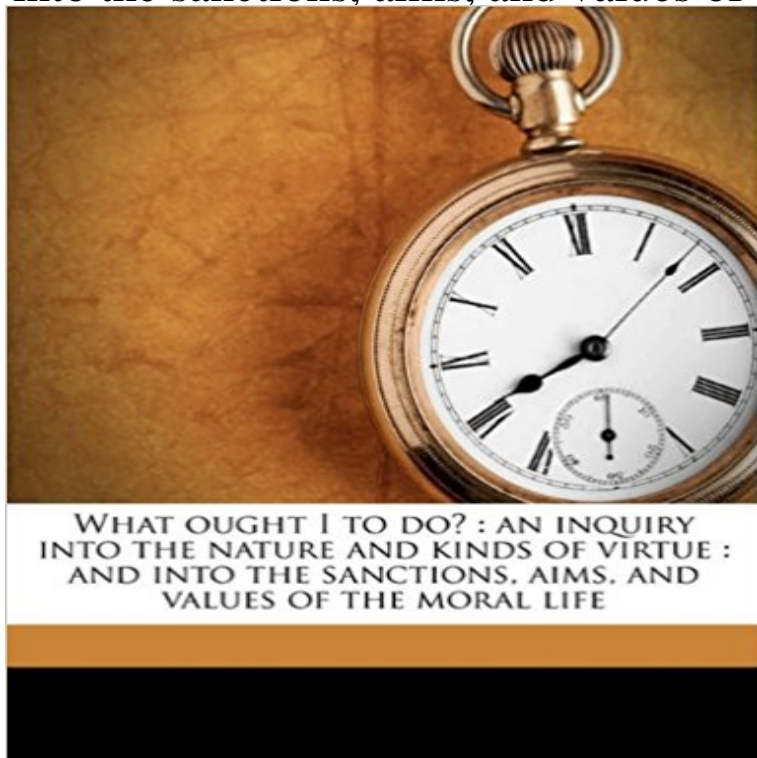


# What ought I to do?: an inquiry into the nature and kinds of virtue : and into the sanctions, aims, and values of the moral life
