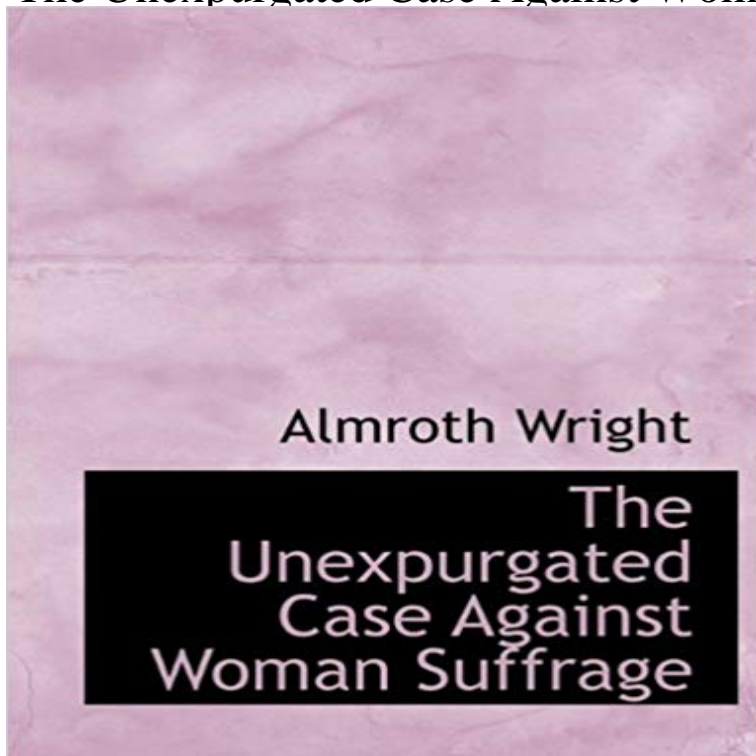


The Unexpurgated Case Against Woman Suffrage
