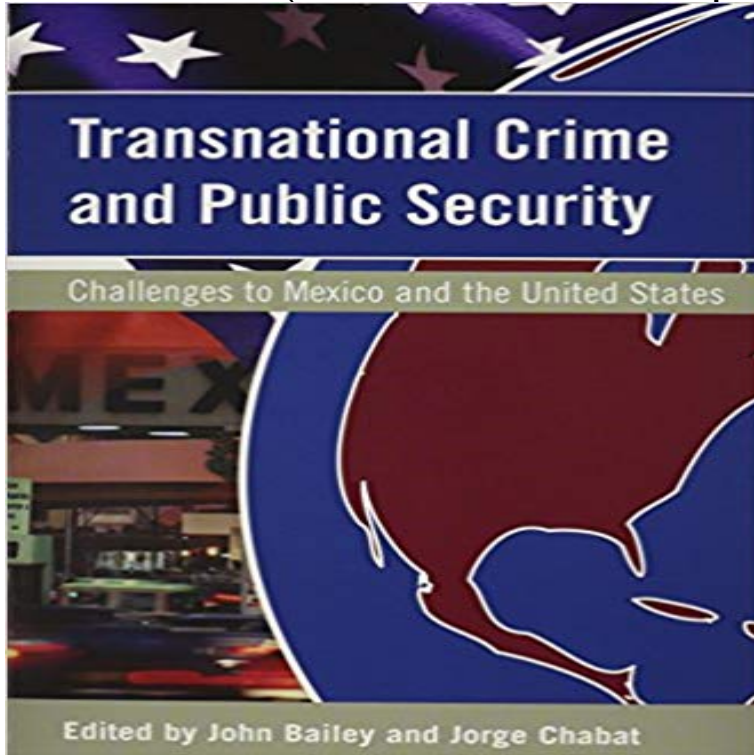


Transnational Crime and Public Security: Challenges to Mexico and the United States (U.S.-Mexico Contemporary Perspectives Series, 18)
